



Cumulation in the EU within Economic Partnership Agreements with African, Caribbean and Pacific countries

Version 10.1.2023

The table below summarizes the current possibilities for EU operators to apply cumulation when exporting under the framework of an Economic Partnership Agreement ('the EPA') between the EU and African, Caribbean and Pacific countries ('the ACP countries').

The table is based on the provisions related to cumulation within each EPA and on the various notices published in the Official Journal (C Series) of the EU concerning cumulation, which remains the legal basis for the application of cumulation.

All the EPAs with ACP countries in force provide for cumulation in the EU, whereby EU operators can benefit from bilateral and diagonal cumulation of non-originating materials and of working or processing carried out in certain ACP countries and in the OCTs.

The said cumulation is subject to the fulfilment of the specific requirements provided for in the protocols on rules of origin of each EPA.

Notes

- a) Columns lists the various EPAs between the EU and the ACP countries in force;
- b) Rows indicates the countries with whom the EU may cumulate;
- c) "√" indicates that cumulation of materials and of working or processing is possible;
- d) "√*" indicates that only cumulation of materials is possible;
- e) § – exports from the EU to Cameroon are governed by Cameroonian Decree No 2016/367 of 3 August 2016
- f) (1) Certain materials are excluded from cumulation - see Notice 2022/C 211/07
