New changes since the CBAM training

- The following slides present the changes by the Authorisation Management Module done since the training of December 2024
- To have the system aligned to the Implementing Act, a series of changes (i.e. "quick fixes") will be introduced before the AMM go-live.
- Since no release will go to PROD before the AMM go-live, some fields will be renamed and code lists will be adapted.




1. Application information: rephrasing of data access status

- In the «Financial and operational details» tab of the application, the field data access status will be renamed from:

3. Application information: Measurement Units- Code list invalidation

- Previously, for the import of chemicals, the unit m^3 was available.
- From the AMM Go-live, m^3 will be invalidated, and the only unit available will be Tonnes, except for electricity, where MWH can be used.
