Guidance for CBAM Declarants on the Request Delayed Submission

During the transitional period, the CBAM Transitional Registry contains a possibility for submitting reports after the deadline stipulated in Regulation (EU) 2023/956 (1).

This possibility is based on a request from the competent authorities in Member States. It is used where customs declarants should have submitted CBAM reports, but such report has not been submitted in the CBAM Transitional Registry. Note that the functionality for reporting declarants to request delay "Requested by Declarant (technical error)" is no longer available in the CBAM Transitional Registry from 1st of October 2024.

The declarant can request to submit a report with a delay by clicking on the "Request delayed submission" button. The "Request delayed submission" button will appear in "My Quarterly Reports" on the day following the submission period due date (e.g., on 01/11/2024 for the Q3-2024 report). Note that the submission period corresponds to the month following the end of the reporting quarter (e.g., November for Q3-2024 and January for Q4-2025).

The "Request delayed submission" button can be used where a <u>draft</u> quarterly report was already created before the submission due date (e.g., 30/09/2024 for Q3-2024) or in case there was <u>no draft</u> quarterly report created before the submission due date.

The functionality to request delay "Requested by NCA²" shall be used only after an interaction between the competent authorities and the declarants. This functionality is meant to allow the submission of reports when the declarant has failed to submit a CBAM within the statutory deadline, upon which a correction procedure is initiated.

The submission and modification periods for delayed report submission varies according to *Table* 1: Submission/Modification Period Deadlines. Note that the modification period corresponds to the month(s) the declarants are permitted to correct a submitted CBAM report. An overview of the submission and modification periods are illustrated in the image below.

STEP 1

The Declarants need to access the Declarant portal à

Then using the dashboard, the user should click on "My Quarterly Reports".



STEP 2

For the appropriate quarter (Q4 2023), the declarants shall click on the "Request Delayed Submission" button.
