#### **KEY FACTS:**

#### **TRADE**

In 2019, the EU's share of world trade was 15.3% with over 850,000 customs declarations being made per day. Every month the 27 Member States export and import goods from and to the rest of the world with a value of around €330 billion

#### **FRAUD**

OLAF recommended the recovery of over €2.7 billion in unpaid customs duties for undervalued goods and €300 million for anti-dumping duty cases in the solar panel, bio-diesel and other sectors between 2017 and 2019.

#### **FAKE GOODS**

Almost **27 million articles** that infringed on intellectual property rights (IPR) were detained in 2018 with a street value of nearly **€740 million**.
