- **7P17** documents required for trade with third countries under the provisions on the control of compliance with marketing standards
- **7P18** documents required for trade in cells, tissues and organs
- **7P19** declaration of the economic operator responsible for the consignment stating that the food or feed does not contain, consists of or was not produced from rice
- **7P20** documents related to the trade in plant protection products
- **7P21** declaration / certificate of conformity
- **7P22** license of the Ministry of the Internal Affairs and Administration to conduct business activities in the field of trading in explosives, weapons, ammunition, as well as products and technologies for military or police purposes, if there is no requirement to obtain a permit from the minister competent for economy for trade in this type of goods
- **7P23** declaration that solid fuels are intended for use in households or combustion installations with a rated thermal power lower than 1MW
- **7P24** declaration on the intended use of solid fuels for purposes other than for use in households or combustion installations with a rated thermal power lower than 1MW

1DK7 – invoice for transport

**1ZC1** – documents required for the application of the relief of goods from import duties as personal property pursuant to Art. 3-11 of Council Regulation No. 1186/2009 establishing a Community system of reliefs from duty

1ZC2 – documents required for the application of the relief of goods from import duties as scientific instruments and apparatus pursuant to art. 44 sec. 1 of Council Regulation No. 1186/2009 establishing a Community system of reliefs from duty or as spare parts, components and accessories for this apparatus on the basis of art. 45 of this regulation

**1ZC3** – documents required for the application of the exemption from import duties as goods intended for charitable or philanthropic organizations and as articles intended for the blind and other disabled persons subject to Art. 61-73 of Council Regulation No. 1186/2009 establishing a Community system of reliefs from customs duties

1ZC4 – documents required for cases other than those specified for codes 1ZC1 - 1ZC3 of application of the relief from import duty on the basis of Council Regulation No 1186/2009 establishing a Community system of reliefs from customs duties

**2DK2** – goods to which CN tariff codes have been assigned the same as to goods from the military list (but also other than CN codes to which EU codes X002 and Y901 are assigned), which, due to their parameters and characteristics, do not qualify for the military category

**2DK3** – a document containing a description of the intended processing referring to the code OPLO7, where the customs declaration is an application for an authorization to use the inward processing, outward processing or end-use procedure

**2DK7** – confirmation of lodging an individual guarantee covering the amount arising from the customs debt, if the guarantee has been lodged (used only on a SAD paper document)

**2DK8** – declaration that the goods declared for release for free circulation after the inward processing procedure met the conditions for benefiting from the tariff preferences in force under the tariff quotas or freight ceilings on the day they are placed under the inward processing procedure, in accordance with Art. 74 DA

**2DK9** – documents, the submission of which is not required by law, but are attached to the declaration, e.g. to fulfill contracting obligations or to secure the generally understood interest of the declarant, exporter / sender or recipient (also other persons related to the transaction or other legal event being the basis of a specific operation). In this category should

be submitted, among others, all kinds of quality, weight and attestation certificates that are irrelevant for the goods classification, issued by producers for the needs of a recipient in a third country

**3DK1** – WPR1 form (reimbursement application)

**3DK5** – agreement establishing a tax representative

**3DK5X** – tax representation for the first time

**3DK6** – documents attached to a collective customs declaration with the 2PL code, containing data related to the description of goods included in the collective customs declaration, as well as senders and recipients, unless the details of senders and recipients of shipments are provided in this declaration

*Note!* This code applies only when the statements / documents / specifications referred to in the description of Boxes 2, 8, 31 and 44 are attached to the collective 2PL declaration, but in the form of a document other than a document with the appropriate code assigned to them in the TARIC database union. Where a document with an assigned Union code acts as such a statement / document / specification, then in Box 44 the "3DK6" code shall not be used, but only the Union code appropriate for a specific document.

**3DK7** – documents confirming the submission of a notification of the intention to import dualuse items used in telecommunications or for information security to the competent monitoring authority (ABW – Internal Security Agency). After the code, the date of signing the above-mentioned document by the person making the notification.

Example: 3DK7 - 20.06.2014

**3DK8** – a certificate or a declaration of compliance with the conditions for not securing VAT and excise duty in the inward processing procedure or temporary clearance with full exemption from import duties, in connection with art. 33 paragraph 7a of the VAT Act and Art. 28 sec. 3 of the Excise Duty Act, submitted with the customs declaration, if such declaration has not been registered in the SZPROT system

**3DK9** — authorization for a special procedure other than the one given after code C601, indicated in the case when the processed product was made of goods placed under the inward processing procedure under more than one authorization (the so-called "combination of authorizations" mode). This code is only present when C601 has been used in the re-export declaration after inward processing (procedure code is '3151')

The code may appear more than once.

**4DK1** – uniform contract of carriage

**4DK2** – the entity's declaration of acceptance of the obligation to pay import duties and tax duties, in the event that the goods referred to in art. 74 of Regulation No 1186/2009 and in art. 63 of the VAT Act would not be granted and the entity's declaration that its accounting procedures enable competent authorities to supervise its activities and that it offers all the guarantees necessary for this purpose

**4DK3** – using other than INF means of electronic exchange of information agreed with the customs authority in relation to Art. 176 sec. 1 lit. a UCC-RD

**4DK4** – a written donation agreement between the taxpayer importing the goods and the entity referred to in § 6a section 2 of the regulation on exemptions from tax on goods and services and the conditions for applying these exemptions (amendment to the above regulation published in Journal of Laws of 2020, item 628) for goods referred to in the description of code 4V6

**4DK5** – contract / agreement / authorization – a document proving the importation on behalf of a state organization or an organization approved by the competent state authorities or on behalf of a rescue unit, entitled to exemption from import duties and VAT pursuant to art. 74 of Regulation No 1186/2009 and Art. 63 of the VAT Act

**5DK1** – goods specification or goods list, if the invoice does not fulfill the specification

**5DK2** – authorization to declare goods, if the customs declaration is made by a representative

**5DK5** – confirmation of submitting the general guarantee for the amount resulting from the customs debt, if the guarantee has been lodged (used only on a SAD paper document)

**5DK6** – documents on the basis of which the taxable base of goods can be determined, if the invoice or other document used to determine the customs value of the goods does not contain the necessary data to determine this basis

**5DK7** – a certificate issued by the manufacturer or an authorized research facility, containing the chemical and raw material composition of the goods (up to 100%) and information required by the notes to individual sections of the Customs Tariff, if such a document is necessary to determine and confirm the tariff classification of the goods

**5DK8** – certificate of issuance of tax bands, specifying the type, series, registration number (if any), date of manufacture, date of issuance of bands, quantity and value of bands, for imported goods subject to banding

**5DK9** – certificate of payment of the amount representing the value of tax bands and the amount representing 80% of the cost of producing tax bands

6DK5 - CN22 customs declaration

6DK6 – CN23 customs declaration

**6DK8** – handover protocol in transmission transport (gas, oil)

**6DK9** – Supplier's invoice with statement of power consumption, when importing electricity

**7DK2** – an invoice issued on the basis of agreed power exchange schedules for the export of electricity

**7DK3** – Bill of Lading, for the import of crude oil

**8DK9** – decision on the repayment or remission of receivables

**9DK8** – other documents (not listed in categories A, B, C) if required by national regulations in connection with import or export

**9DK9** – other documents (not listed in categories A, B, C) if required under EU regulations in connection with import or export

*Note!* If you enter in Box 44 documents from both of the above-mentioned category "other documents", after the codes 9DK8 and 9DK9, after the dash, the name of the document is given, and then the designation of the document after the next dash

Example: 9DK8 - Safety Certificate - 11MG2334CB0002
