# MAKING VAT RULES WORK FOR ONLINE BUSINESSES



Modern and simpler VAT rules for businesses selling goods and services online crossborder within and to the EU



Making it easier for online businesses to access other markets



Ensuring EU businesses are on an equal VAT footing with non-EU competitors



Companies can declare and pay VAT on their sales in the entire EU in a single quarterly, electronic return



Allowing companies with total cross-border sales of less than €10,000 to take care of their VAT as if they were selling at home



Enabling Member States to apply the same VAT rates to e-publications as they do for their printed equivalents



Online sales in the EU are worth €550 billion a year – €96 billion of which is cross-border

The new rules will raise **€7 billion in VAT revenues** for Member States from 2021

A new system for **cross-border VAT collection** on online goods and services will give **430,000 businesses** better access to EU trade

## HOW DOES THE 'ONE STOP SHOP' ONLINE VAT PORTAL WORK?

The One Stop Shop is an online portal which simplifies VAT obligations for businesses selling goods and services to consumers throughout the EU, allowing them:

to register for VAT electronically in a single Member State for all sales of goods and services;

to declare and pay the VAT due on all these sales of goods and services in a single electronic quarterly return;

to work with the tax administration of their own Member State, and in their own language, even though their sales are cross-border.

### WHAT IMPACT WILL OUR PROPOSALS HAVE?



#### THE SYSTEM IS PROVEN. IT WORKS.

This system, known as the **Mini One Stop Shop**, is already in place for companies selling e-services across borders within and to the EU since 1 January 2015.

It's now being extended to help online companies selling goods and other services cross-border.

The **One Stop Shop** is complemented by an online information portal for sellers, which is consulted nearly 17 000 times a month. The portal will be enhanced in early 2017 to make it more user-friendly for thousands of businesses. This portal will also play an integral role in the move to the One Stop Shop.
