

SAMANCTA — eLearning module

This easy-to-use eLearning module is one of the courses from an extensive EU eLearning programme for Customs and Tax.

This course guides you through the online quick reference support tool intended to provide a guideline for sampling goods for customs and tax purposes: **SAMANCTA** (Sampling Manual for Customs and Tax Authorities).

SAMANCTA is designed to harmonise procedures for samples taking, provides constructive guidance to customs officers on the sampling methods, address health and safety issues.

The benefits of using SAMANCTA are to maintain a high level of quality and consistency in the samples taken, ensure every sample meets the requirements for official testing purposes, create a standard approach for the labelling, storage and transportation of samples, and ensure the chain of evidence is not broken as everyone follows the same sampling plan.

To fully benefit of the potential of this course, we recommend to integrate the course in your own training programme and to develop a full blended learning programme.

By the end of this course, you will be able to:


- understand the purpose and legal relevance of SAMANCTA,

Particularities of this course

This course is focused on demonstration methods: show-me, try-me.

It features activities used for presenting how the tool works, or how it should be used. They consist of step-by-step demonstrations with precise explanations for each of the actions presented.

According to the complexity of the component, either a show-me or a try-me type of activity is used.

You may interrupt your course. When reopening the course you can resume where you have left the course off. The completed sections are indicated in blue in the menu.

Beside the menu, a course map allows you to quickly access to the sections and subsections. The course map is placed in the upper toolbar of the course.
