Chapter 41

Raw hides and skins (other than furskins) and leather

Chapter note:

For the purposes of split headings 4104(c), 4105(c) or 4106(c) the retaining of crust is to be considered as origin conferring, on the condition that the products are subject to a wet-end process whereby they are retained, fatliquored and dyed prior to being further prepared.

Chapter residual rule:

Where the country of origin cannot be determined by application of the primary rules and the other Chapter residual rule[s], the country of origin of the goods shall be the country in which the major portion of the materials originated, as determined on the basis of the value of the materials.
